3 PURPOSE

These Program Regulations apply to all students enrolled in the Master of Health Professional Education.

4 OVERVIEW

4.1 Campus Availability

The Graduate Certificate in Health Professional Education, Graduate Diploma of Health Professional Education and the Master of Health Professional Education has been approved for delivery from the Fremantle Campus.

4.2 Student Availability

The Graduate Certificate in Health Professional Education, Graduate Diploma of Health Professional Education and the Master of Health Professional Education is available for enrolment to domestic students and offshore students.

4.3 Australian Qualifications Framework

The Graduate Certificate in Health Professional Education and the Graduate Diploma of Health Professional Education are accredited by the University as a Level 8 AQF qualification. The Master of Health Professional Education is accredited by the University as a Level 9 AQF qualification.

4.4 Duration

The Volume of Learning for the Graduate Certificate in Health Professional Education is 0.5 years of equivalent full-time study.

The Volume of Learning for the Graduate Diploma of Health Professional Education is 1 year of equivalent full-time study.

The Volume of Learning for the Master of Health Professional Education is 1.5 years of equivalent full-time study.

A student is able to enrol in this Award only on a part-time basis.

4.5 Maximum Duration

The maximum period of time within which a student is permitted to complete the Graduate Certificate in Health Professional Education Award is 3 years (including any periods of approved leave of absence) from the date on which they were first enrolled into the program by the University.

The maximum period of time within which a student is permitted to complete the Graduate Diploma of Health Professional Education is 5 years (including any periods of approved leave of absence) from the date on which they were first enrolled into the program by the University.

The maximum period of time within which a student is permitted to complete the Master of Health Leadership is 7 years (including any periods of approved leave of absence) from the date on which they were first enrolled into the program by the University.

4.6 Study Mode

These awards are offered fully online.

4.7 Professional Accreditation

There are no professional accreditation requirements applicable to this Program.

7 PROGRAM REQUIREMENTS

7.1 Program Descriptions

Graduate Certificate in Health Professional Education

This Graduate Certificate in Health Professional Education is a highly practical degree designed to meet the unique learning needs of educators in health professional contexts who wish to extend their understanding of learning theory to their workplace. This postgraduate program is aimed at health professional educators in medicine, nursing and allied health settings in academic and/or clinical contexts. Acknowledging complex lives and multiple priorities this degree is flexible. The self-directed courses are delivered fully online, allowing content to be accessed at a time, place and pace that best suits you. This postgraduate degree, extends your understanding of learning theory, contemporary educational issues, clinical reasoning and supervision. The Graduate Certificate in Health Professional Education is an articulated qualification that forms the foundation for the Graduate Diploma and/or Master of Health Professional Education.

Graduate Diploma of Health Professional Education

This Graduate Diploma of Health Professional Education is designed to meet the unique learning needs of health professional educators in medicine, nursing and allied health settings in academic and/or clinical contexts. Acknowledging complex lives and multiple priorities this degree is flexible. The self-directed courses are delivered fully online, allowing content to be accessed at a time, place and pace that best suits you. Learners will extend their foundational knowledge and skills in educational theory and practice, clinical reasoning and supervisory role to explore their professional development in the context of their specific educational practice. This qualification provides a foundation for health professionals looking to expand their knowledge, skills and affective learning.

The Graduate Diploma of Health Professional Education is an articulated qualification that forms the foundation for the Master of Health Professional Education.

Master of Health Professional Education

This Master of Health Professional Education is designed to meet the unique learning needs of health professional educators in medicine, nursing and allied health settings in academic and/or clinical contexts. The program will provide the learners with a wide repertoire of educational skills that are specifically tailored to a range of learning needs and challenges in contemporary health education contexts. The program encourages you to develop your educational skills in both clinical and non-clinical environments. Acknowledging complex lives and multiple priorities this degree is flexible. The self-directed courses are delivered fully online, allowing content to be accessed at a time, place and pace that best suits you. This qualification will provide a pathway for you as a health professional interested in developing your educational practice, ultimately preparing you to become an exemplary educational leader. Learners will be encouraged to innovate and lead purposeful change in their health professional context.

4. Develop sophisticated understandings of unique nature of learning and teaching in the health context
5. Develop educational initiatives that enhance best practice principles in the often unpredictable workplace/clinical health context.
6. Evaluate key ethical issues and traditions that inform and shape professional conduct, particularly as these relate to learning and teaching
7. Develop a comprehensive and practical understanding of research methods and how to apply these methods to educational research in the healthcare context
8. Develop skills in identifying and interrogating hypotheses or research questions
9. Create new knowledge by conducting, evaluating and collaboratively reflecting upon defensible research into a health professional educational issue.

7.3 Required Courses

To be eligible for the award of **Graduate Certificate in Health Professional Education** students must complete a minimum of 25 Units of Credit consisting of the one (1) Compulsory course listed in Appendix A.

To be eligible for the award of **Graduate Diploma of Health Professional Education** students must complete a minimum of 75 Units of Credit consisting of the three (3) Compulsory Courses listed in Appendix A.

To be eligible for the award of **Master of Health Professional Education** students must complete 175 Units of Credit consisting of the five (5) Compulsory Courses listed in Appendix A.

7.4 Elective Courses

There are three (3) Elective Courses in the **Graduate Certificate in Health Professional Education** giving 75 Units of Credit.

There are five (5) Elective Courses in the **Graduate Diploma of Health Professional Education** giving 125 Units of Credit.

There are five (5) Elective Courses in the **Master of Health Professional Education** giving 125 Units of Credit.

7.5 Nested Awards

To be eligible for the award of **Graduate Diploma of Health Professional Education** students must complete a minimum of 200 Units of Credit consisting of the courses listed in Appendix A.

To be eligible for the award of **Master of Health Professional education** students must complete a minimum of 300 Units of Credit consisting of the courses listed in Appendix A.

7.6 Course substitutions

Course substitutions, where permitted, must be approved by the Dean.
